The company must be a public-listed company in the Asia-Pacific region with a market capitalization between US\$50 million and US\$10 billion as at 31 November 2017. - 2. The Asia-Pacific region markets include Singapore, Malaysia, Thailand, Indonesia, Philippines, Vietnam, Hong Kong, China, Taiwan, Korea, Australia, New Zealand, India and Japan. You may refer to https://hiddenchampionsfund.com/#halloffame for possible ideas. Bonus marks will be given to those who can discover companies outside of the Hall of Fame. You are encouraged to engage in a discussion/dialogue about your choice of the company with the Hidden Champions Fund investment team at invest@hiddenchampionsfund.com.
- 3. The written report must be submitted with the **Calibri** font and font size **11** with no spacing between the lines of text or paragraphs.
- 4. Both the written report and presentation slides must be submitted in the form of PDF.
- 5. Both the written research report and presentation slides will have no limitations on the number of pages or slides, though succinctness, clarity and organization in analysis is strongly encouraged. Aim to be "analytical" and not "descriptive" in your approach. Submit by **13 December 2017, 2359 hrs**. All sources must be cited. (Include link to guiding questions)

Finals (Live)

The finals will be conducted at Singapore EXPO on 28th January 2018. Rehearsals will be pre-arranged and notify to the top 4 teams on 26th January 2018.

The order of presentation will be determined by a random ballot.

The presenting teams must present the same company they have prepared for the preliminary rounds.

Each presentation is 20 minutes, followed by 10 minutes of Q&A session.

The organiser will prepare copies of each team's presentation slides for the judges.
